It is apparent there is a lot of pride and support for Ellendale Country Club. It is my challenge and goal to return Ellendale to its rightful place as one of the premier private clubs in the state. There is a significant amount of work ahead of us but I am confident we have the right Staff and Board of Directors in place to put us back where we should be.

MAINTENANCE MINUTE

We have had many questions about the inconsistency of the greens during the spring and the overall health as it relates to the putting greens. The main factor is the inconsistency of the poa-trivialis overseed on the greens that is resulting in faster greens on the front nine and slower greens on the back. As temperatures get into the 80's we will begin to thin out the overseed and regain the consistent roll of the mini-verde bermuda that will take over as temperatures increase.

We have increased the fertilizer on the driving range and modified mowing practices to increase turf strength and reduce the amount of sand on the tee. We will be increasing our fertilizer and chemical programs to better balance the health and playability of the greens, tees and fairways.

There will be occasional mornings where we will keep the course closed early to allow us an opportunity to verti-cut and/or top dress the greens. Please be patient as we focus on improving the overall health and quality of the course.

Flowers and shrubs have been planted in front of the golf shop. Special thanks to the Garden Club for beautifying these areas.
